This is an international application procedure and follows the guidelines stated in the ECPDESP Polytechnic Teacher Career Statutes and the Polytechnic Teacher Application Regulation of the IPC approved by Law nº 9208/2010, published in *Diário da República*, 2nd series, nº 104, of the 28th of May of 2010, declares open the international competition, for a period of 30 business days, from the day this notice is published in *Diário da República*, under a long term contract, for the position of 2 (two) Assistant Professors in the Scientific Area of Dietetic and Nutrition in Coimbra Health School.

- 1 Workplace *Escola Superior de Tecnologia da Saúde de Coimbra* Coimbra Health School.
- 2 Salary and functions General functions of university level teachers are defined in art. 2º-A of the ECPDESP and all functional contentes of this category of teachers are the ones defined in art. 3º, nº 4, of the ECPDESP. To the category of Assistant Professor corresponds the remuneratory position published in Decree-Law nº 408/89, of 18 of November with the new amendment introduced by Decree-Law nº 76/96 of 18 of June and by Decree-Law nº 212/97 of 16 of August.
- 3 Validity of the application This application procedure is valid for the positions published.
- 4 Requirement of admission:
- 4.1 General Requirements In accordance with the mentioned Statutes, the application procedure has the following requirements according to article 17° of General Law for Public Workers, approved by Law n° 35/2014 of 20 of june:
- a. Has completed the minimum age of 18,
- b. Allowed to work in public services,
- c. All vaccines recommended by law,
- 4.2 Specific Requirements Applications follow the requirements according to article 17º of ECPDESP, applicants must have a Doctorate PH.D or any other specialising title in this area. Candidates with academic titles from other countries must prove these academic titles in terms of the portuguese law.
- 4.2.1. The scientific area of this application procedure is Nutrition Sciences.
- 5 Outline, deadline and language of the application The applicants have to submit the following documentation in paper, through registered mail to the address *Instituto Politécnico de Coimbra, Av. All documents required must be in portuguese or english.
- 6 Instructions.
- 6.1. The application must be presented with correct application form addressed to the President of the *Instituto Politécnico de Coimbra*, with the following information full name, parents name, date and date of birth, number and date of identity card, address, telefone number, email, personal status, academic degrees and final mark, professional category, number of application procedure, edital number with reference of the date of

publisment in *Diário da República*, such as all documents required for the application procedure.

- a. Photocopy of identity card or citizen card or other identification card valid in the EU passport.
 - b. Photocopy of portuguese tax-contributor card,
- c. Six copies of the *Curriculum Vitae* and these must include date and applicants signature.
 - d. Six copies of the application form specifically for this procedure.
- e. A writen declaration of the candidate which insures that he is not under any prohibition to develop public services or having any physicall or psycological problems that might directly affect his teaching funtions and has all vaccines recommended by law.
 - f. DVD with a digitalized copy of the application form and documents required.
- 6.3. The Curriculum Vitae must include:
 - a. Full name of the applicant.

- 9.3 Both lists of applicants are published and applicants are informed, according to the Portuguese Administritive Code .
